The following revisions and changes shall be made a part of the contract bidding documents:

1. Changes to **SPECIAL PROVISIONS:**

- a. Page SP-7: **DELETE & REPLACE** "SECTION 304.05 BOOSTER PUMPING UNIT", Item B.1.a.i.4), with the following:

"Pump shall be Layne 6GM, *Simflo SD7C* (Kahalu'u Booster A & B) or approved equal and Goulds/Gicon 9RCHC (Kahalu'u Booster D) or approved equal. See Item 6, CONTROL OF MATERIALS AND EQUIPMENT on page IB-11 for details."

- b. Page SP-7: **DELETE & REPLACE** "SECTION 304.05 BOOSTER PUMPING UNIT", Item B.1.a.ii.1), with the following:

"Pump rated capacity and head: 250 GPM at 505 ft. head @ motor full load RPM. (Bowl efficiency not less than 77.0%)."

- c. Page SP-7: **DELETE & REPLACE** "SECTION 304.05 BOOSTER PUMPING UNIT", Item B.1.a.iii.1), with the following:


"Pump rated capacity and head: 500 GPM at 505 ft. head @ motor full load RPM. (Bowl efficiency not less than 82.0%)."

2. **CLARIFICATION:**

Booster A repair work shall be completed and accepted by the Department prior to starting any work on Booster B.
