

## **NOTICE TO BIDDERS**

(Chapter 103D, HRS)

SEALED BIDS for INSTALLATION OF WASHRACK, KAHULUI AIRPORT, KAHULUI, ISLAND OF MAUI, STATE PROJECT NO. AM1049-14, will be received at the Contracts Office, Department of Transportation (DOT), 869 Punchbowl Street, Honolulu, Hawaii 96813, or at the Office of the District Engineer – Maui, 650 Palapala Drive, Kahului, Hawaii, 96732, until 2:00 p.m., Hawaii Standard Time (HST), June 16, 2016, at which time and place(s) they will be opened and read. Bids received after said due date and time shall not be considered.

The scope of work consists of installing an individual concrete washrack, asphalt concrete access road, individual oil/water separator assembly with diversion valve and control panel, and a lined evaporation pond. Work also includes trenching, backfilling, utility connections, concrete paving, electrical lighting, drainage, and erosion control. The estimated cost of construction is between \$1,000,000 and \$1,500,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.

A compact disc containing the plans, specifications, and proposal contract forms may be obtained from the said bid receiving office(s). Bids (hard copies) shall be submitted in a clearly identified sealed envelope, and be on the Proposal Form provided on the compact disc furnished by the DOT. The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall

submit a Certification for Hawaii Product Preference (SPO Form 38) to the DOT Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is scheduled for 10:30 A.M., May 31, 2016, at the Honolulu International Airport, Inter Island Terminal Building, 7<sup>th</sup> floor Conference Room A, 400 Rodgers Blvd., Honolulu Hawaii 96819. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. 
