SEALED BIDS to CONSTRUCT & DELIVER RESTROOM TRAILER TO KONA INTERNATIONAL AIRPORT, ISLAND OF HAWAII, PROJECT NO. CH2722-43, will be received at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Honolulu, Hawaii 96813, or at the office of the District Engineer – Hawaii, 50 Makaala Street, Hilo, Hawaii 96720 until 2:00 p.m., Hawaii Standard Time (HST), September 8, 2016, at which time and places they will be publicly opened and read.

Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the Department of Transportation Contracts Office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the Department.


