SEALED BIDS for RE-UPHOLSTERING HOLD ROOM CHAIRS, KAHULUI AIRPORT, ISLAND OF MAUI, STATE PROJECT NO. CM1702-43, will be received at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Honolulu, Hawaii 96813, or at the office of the District Manager – Maui, 620 Palapala Drive, Kahului, Hawaii 96734, until 2:00 p.m., Hawaii Standard Time (HST), December 15, 2016, at which time and place(s) they will be publicly opened and read.

A compact disc containing the specifications, proposal and contract forms may be obtained from the above office. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The scope of work consists of re-upholstering hold room chairs in accordance with the specifications. The estimated project cost is between \$450,000 and \$1,000,000.

The Hawaii Products Preference pursuant to ACT 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the Department of Transportation Contracts Office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the Department. A separate SPO-38 form shall be completed and submitted for each product. prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.
