

NOTICE TO BIDDERS

SEALED BIDS for FURNISHING OF HIGHWAY TRAFFIC CONTROL AT VARIOUS LOCATIONS, ISLAND OF HAWAII, PROJECT NO. HWY-HM-2016-01, will be received at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Honolulu, Hawaii 96813 or at the Office of the District Engineer – Hawaii, 50 Makaala Street, Hilo, Hawaii 96720, until 2:00 p.m. Hawaii Standard Time (HST), July 28, 2016, at which time and place they will be publicly opened and read.

A compact disc containing the specifications, proposal and contract forms may be obtained from the above offices. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The scope of work consists of furnishing traffic control personnel (flagger) and labor for highway traffic control twenty-four (24) hours a day, seven (7) days a week on an indefinite quantity/ “as-needed” basis.

The Hawaii Products Preference pursuant to ACT 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the Department of Transportation Contracts Office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the Department.
