Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The project includes guardrail, terminal section and impact attenuator system repairs on the Island of Hawaii on an “as-needed” basis.

To be eligible to bid, bidders must possess a valid State of Hawaii General Engineering Contractor’s “A” license or Specialty Contractor’s “C-32”, license, prior to bidding.

The Hawaii Product Preference pursuant to Act 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a

Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the DOT Contracts office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. A pre-bid conference is set for 10:00 a.m. on August 2, 2016 at the Department of Transportation, Highways Division – Hawaii District, 50 Makaala Street, Hilo, Hawaii 96720. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory


