A compact disc containing the plans, specifications, proposal, contract forms, and applicable National Pollutant Discharge Elimination System Permit documents, may be obtained from the above office. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

**The project includes construction of an area for administering on-road skills tests for CDLs and motorcycles and the renovation of an existing building to be used as an office. The scope of work for the new testing site involves excavation for roadway, drainage systems, ditch and channel, drainage improvements, landscaping, installation of Portland cement concrete pavement, jersey barriers around existing structural**

**columns, chain link fence, striping and signage, and reconstruction of a portion of Second Street. The scope of work for the proposed testing office area includes cold planning and resurfacing the existing parking lot with Hot Mix Asphalt pavement, striping, signage and renovation of the existing structure.** Estimated construction cost is between \$5,000,000 and \$10,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license, at the time of bidding.

The Hawaii Products Preference pursuant to Act 175, SLH 2009, is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO-Form 38) to the DOT Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall be completed and submitted for each product. Forms are available at <http://www.hawaii.gov/forms.com>.

A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is set for 9:30 A.M., May 27, 2016, at the Department of Transportation, Highways Division, Kakuhihewa Building, 601 Kamokila Boulevard, Room 577A, Kapolei, Hawaii 96707. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. Anything said at the conference is for clarification purposes and any changes in the bid documents will be made by addendum. 
