SEALED BIDS for the FURNISHING OPERATION, MAINTENANCE, REPAIR, INSPECTION AND PUMPING SERVICES FOR THE LANDA WASH-WATER TREATMENT SYSTEM AND VEHICLE CLEANING SERVICES AT KEEHI BASEYARD, PROJECT NO. HWY-OM-2016-33, ISLAND OF OAHU, will be received at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Honolulu, Hawaii 96813 until 2:00 P.M., Hawaii Standard Time (HST), November 17, 2016, at which time and place they will be publicly opened and read.

A compact disc containing the specifications, proposal and contract forms may be obtained from the above office. Bids (hard copies) shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

The scope of work consists of operating, maintain, repairing, inspecting and furnishing pumping service for the existing Landa Wash-Water Treatment System and washing, vacuuming and polishing various State vehicles, trucks and large equipment at the Department of Transportation, Highways Division Wash Rack, located at the Keehi Baseyard, on an indefinite quantity/ "as-needed" basis.

To be eligible for award, bidders must be currently registered as a Wastewater and Wastewater Sludge Pumper and Hauler with the State of Hawaii, Department of Health, Wastewater Branch (DOH WWB) at the date of bidding. Bidder's attention is directed to Section 2.1 of the Special Provisions regarding bidder's qualification.

The Hawaii Products Preference pursuant to ACT 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the Department of Transportation

Contracts Office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the Department.
