2. CHANGES TO DRAWINGS

Descriptive Drawing Changes: The following previously issued drawings are revised as follows.

- A. Sheet A-22.2 – Insert bubble “F2.6A” instead of “F2.6” at East Elevation Unit 22C’s deck. Five decks total to be replaced at building 22 to match Sheet A-22.1.

- B. Sheet A-22.2 – Insert bubble “F2.6A” instead of “F2.6” at North Elevation Unit 22C’s deck. Five decks total to be replaced at building 22 to match Sheet A-22.1.
- C. Sheet S-2.8 – Delete note “DCK” at Unit 22D’s living room entry. Five decks total to be replaced at building 22 to match Sheet A-22.1.

All other terms and conditions shall remain in full force and effect.
